As a personal Sevak, I used to accompany Swamiji to all places of his visit. I used to move very closely with him as his personal sevak. I had also accompanied him to all places of his visit not only in India but also abroad many a times.

- 4. Since from the date of joining the Ashram till this day, I along with the other inmates of Ashram, i.e., from Junior Level to Senior Level Ashramites, are living in the Ashram like brothers and sisters as one family in a most calm, cool and spiritual atmosphere by participating in all spiritual programmes conducted by the Ashram by dedicating ourselves to the Ashram.
- This being the fact situation, a certain lady by name Aarathi, came to 5. our Ashram sometime during the year 2004 with many personal problems losely with him as his personal sevak. I had also accompanie and on being attracted by the spiritual programmes conducted by the Ashram, she started visiting Ashram quite often. Arathi who came to our Ashram for solutions to her personal problems subsequently, when her problems got solved/improved, she got more and more attracted by the spiritual whram like brothers and sisters as one family programmes conducted by the Ashram. After some time, Swamiji had called all of us to assemble in the Meditation Hall of the Ashram and when we all assembled, Swamiji advised Aarathi to conduct herself well and to follow the set and adopted Rules and Regulations of the Ashram strictly without giving any room for any unwarranted events and further advised all of us to put our sincere efforts to maintain the decorum and dignity of the Ashram. He also brought to our notice that our aim shall be towards spreading spirituality to the maximum extent and certainly not to indulge in advised me that he would certainly take care of these any unwarranted activities. Further, I would like to state that being a personal sevak to Swamiji since the last over 8 years, virtually being his shadow, to my knowledge, we never allowed any female Ashramite to the place where Swamiji is staying. Being the personal sevak of Swamiji, I used to accompany him to all places not only in India but also abroad. The practice in our Ashram is to allocate rooms in the Ashram for male and female Ashramites separately. Likewise, whenever the spiritual programmes are conducted outside the Ashram, we would follow the same principle strictly. At no point of time, Aarathi was called to the room of Swamiji as alleged by her in her statement, be it in the Ashram or at any other place. Further, being the personal sevak of Swamiji, I am certain that no incident as projected by Aarathi in her statement has taken place. Her statement is patently false, frivolous and baseless.
- Swamiji throughout as I was his personal sevak. I was with him during his travel in the caravan to take care of his needs.
